# 7. Eligibility and Entry

U13 players shall be under 13 years of age on the 31st December immediately before the start of the year in which the tournament take place (players born on or after 01.01.2012. and younger).

Entries are open to:

# 7.1. Athletes of the ETTU Members Associations, except those defined under 7.2.

- 7.1.1. can enter only one team, maximum three boys and three girls
- 7.1.2. shall be entitled to enter up to 6 players for Individual events, consisting of not more than 3 players participating in U13BS, 3 players participating in U13GS and 6 players in XD events.
- 7.1.3. are allowed to enter players only for Individual events.

# 7.2. Athletes of ETTU Members Associations with Belarusian or Russian passport as Individual Neutral Athletes (AIN) as follows:

7.2.1. may enter only in singles and mixed doubles events, maximum three boys and three girls.

# 7.2.2. Conditions of AIN participation:

- 7.2.2.1. AIN may be entered if they submitted to the ITTF the ITTF Additional Terms of Participation document and be granted acceptance by ITTF.
- 7.2.2.2. AIN may participate if the responsible authorities accept their entry into the hosting country.

## 7.3. Composition of Mixed Doubles

7.3.1. it is allowed to pair players from different Association.

Seeding for team events shall be based on the **2025 September European U13 Ranking**, considering the number of individual ranking points for the two highest-ranked boys and two highest-ranked girls in the team.

Seeding for the individual events shall be based on **2025 September European U13 Ranking.** The Ranking Committee may give special seeding positions to players who are high in the U13 WR, but not in the U13 ER. The National Association of the Players must send a written request to the Competition Manager and the ETTU Ranking Committee within three (3) days of the final entry deadline.

The Jury meeting with team delegates will take place at the venue on Tuesday, 23.09.2029. at 19:00 local time.
